Pricing is based on an agreed number of tests, and all test takers must be employed by the customer's organisation, with an organisational email address. Minimum purchase 5000 tests (£7,500).

Buyers are free to resell the tests to clients, but we reserve the right to withdraw the facility if tests are resold above the £5 per test rate.

Other Pricing

Set-Up Costs:

Bias Test works by setting up bespoke test links loaded with your chosen tests, for your chosen test population. Per Test pricing attracts a set-up fee of £10 per link. For example, if you want to test all new staff with Ethnicity and Gender tests, that link would cost £10 to set up.

Analysis & Report Writing

Data from tests can be directly downloaded by the customer in MS Excel format. The system deletes all personal data on download. We offer an analysis and report writing service. Costs vary depending upon the size of the testing and the complexity of the analysis and report writing required.

Other FAQs

Freedom of Information Act:

Test results belong to the test taker and cannot be disclosed to the employer or other body without their consent or due legal process. Personal test data is deleted between 90 days and 120 days after testing and cannot be retrieved. Individual test takers can ask that their test results be deleted at any time and this request will be executed unless there is a legal order prohibiting deletion.

GDPR:

We are registered with the Information Commissioner to process data and our servers are in Germany. A general and comprehensive DP agreement appears on our web site.

Data Security:
